INTERNS:

1. **RECEIVE NEW CASES & DATA ENTER CASE INFORMATION INTO DATABASE.**
2. **REVIEW CASES AND IDENTIFY APPROPRIATE CRIME CLASSIFICATIONS.**
3. **ACQUIRE KNOWLEDGE OF NYS PENAL CODE.**
4. **OBSERVES INTERVIEWS AND OR INTERROGATIONS OF PERPETRATORS, COMPLAINANTS AND WITNESSES.**
5. **RESPONSIBLE FOR RECEPTION DUTIES WHICH INCLUDE IN PERSON VISITS AND PHONE INQUIRIES. VARIOUS CLERICAL DUTIES MAY ALSO BE INCLUDED.**
